- John Hardman moved to approve the North Star General Appropriations Act. General Fund Revenues are estimated at \$212,130 and Expenditures at \$138,064. Cemetery General Fund Revenues are estimated at \$30,400 and Expenditures at \$33,700. Fire and Rescue Revenues are estimated at \$10,000 and Expenditures at \$0. Sewer Operating Revenues are estimated at \$100,200 and Expenditures at \$55,843. Roads Fund Revenues are estimated at \$172,600 and Expenditures at \$145,700. Second by Bill Smith. Upon a roll call vote, the Act passed unanimously.
- John Hardman moved to approve Budget amendments as presented by Clerk Heidi Drowley. Second by Nicole Whitmore. Motion carried.
- Bill Smith moved to approve the following Gratiot County Road Commission contracts for 2023-2024:
  - Chloride contract for 4 full applications in the amount of \$67,977.80
  - Gravel contract for 9.70 miles of gravel in the amount of \$74,205Second by John Hardman. Motion carried.
- Heidi Drowley to hire Yeo & Yeo to complete a required bi-annual audit for fiscal year ending March 31, 2023 for a fee of \$9,650 plus additional fees for other auditing services. Second by Danielle Wolfe. Motion carried.
- John Hardman offered Resolutions to increase the Supervisor, Clerk, and Treasurer salaries to \$11,000 per year and maintain the Trustee salaries of \$1,260 per year plus \$20 per meeting. Second by Heidi Drowley. Upon a roll call vote, the resolutions passed unanimously.

**SAVINGS ACCOUNTS** – In looking for ways to better invest the Township's excess monies, the Board discussed transferring excess funds into Savings Accounts at Isabella Bank with a current interest rate of 4.5%. We will look into the possibility of cashing in current CDs with lower interest rates and depositing into the higher interest rate Savings accounts. Other investments options were discussed but the Board is in agreement that this is the best option for North Star Township.

They also thought that previous suggestions they had given to the board had been acted on and were in place because they never heard back from anyone. The board apologized for not getting back with them but that no changes had been made to the cemetery rules that were adopted in 2021. The board will contact the mowing company regarding spring clean-up. One committee member asked what the cemetery's fund balance was when the board took over in 2010 and what the fund balance is now. The earliest fund balance found was in June of 2012; \$11,124 and the current fund balance as of March of 2022 is \$49,731. Our last Cemetery General Fund CD of \$14,067 was cashed in during the 2014 fiscal year.
